1. Scope:

a. Scope of use: When using the iFWD Taiwan website, the use and protection of any and all collected personal information.

2. Policy:

Only in the following circumstances will this website share your personal information: (1) After explicit permission or authorization from the user (2) Upon request from judicial parties or other competent authorities in accordance with lawful procedures (3) When providing users with other services or promotions and personal information will need to be shared with third parties in order to provide this service. Under this circumstance, the website will provide a full explanation and give the user the choice to accept or reject the services / benefits.
